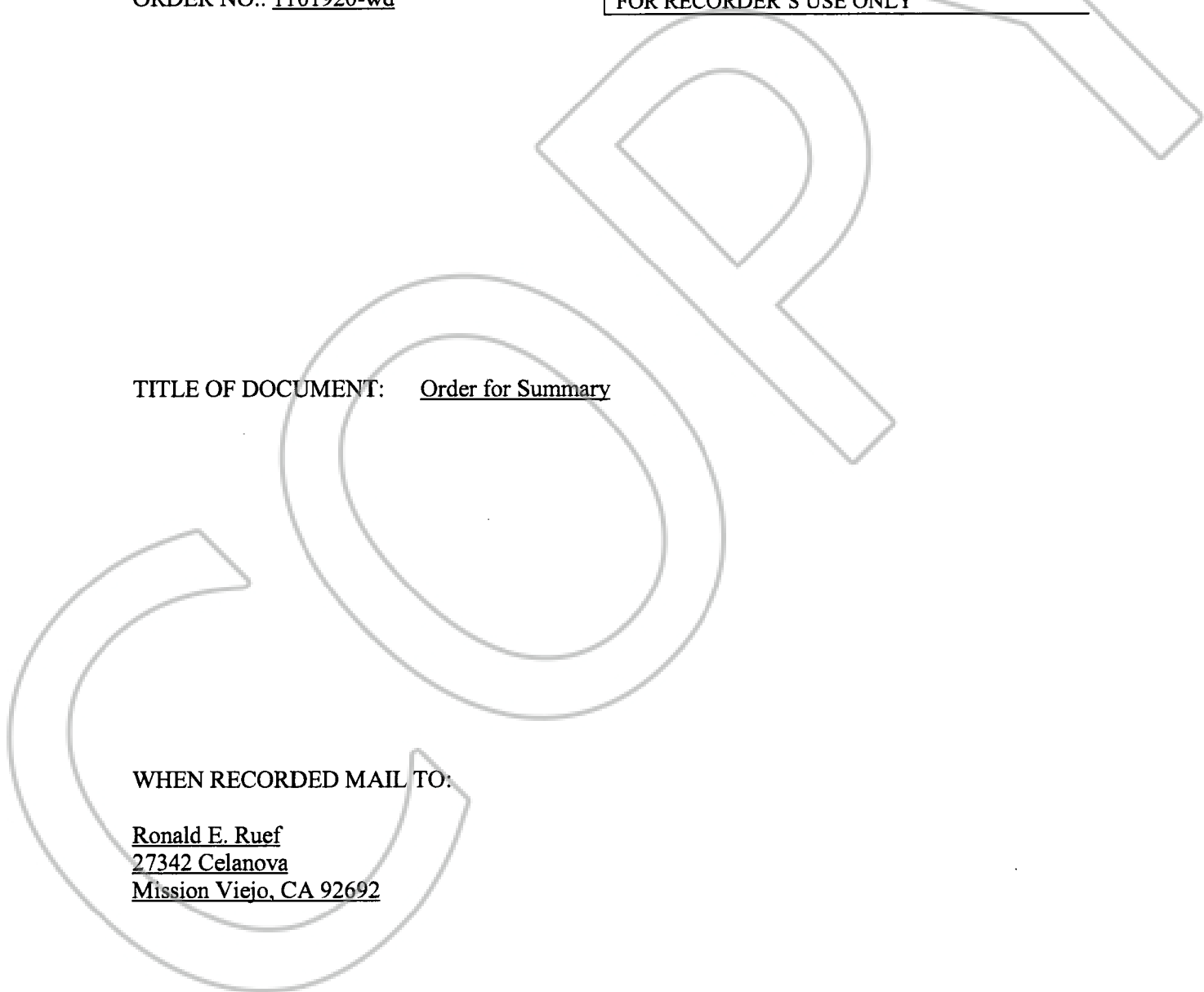

**ORDER FOR SUMMARY
ADMINISTRATION AND FOR ISSUANCE
OF LETTERS TESTAMENTARY**

The petition of RONALD E. RUEF praying for Summary Administration of Estate and for Issuance of Letters Testamentary came on for consideration at the scheduled hearing. After considering the petition, the law and the evidence the Court finds that:

1. Due notice of the hearing on the petition was given as required by law.
2. The Decedent, ANN RUEF BOSTWICK, died on February 7, 2013.
3. The Decedent left a Last Will and Testament dated June 30, 1995. The original of the Will is on file with the Court.
4. The Decedent died leaving an estate subject to the jurisdiction of this Court.
5. Petitioner, RONALD E. RUEF, is qualified for and entitled to Letters Testamentary pursuant to the laws of the State of Nevada. The Court finds that no bond shall be required of the Petitioner.
6. The gross value of the Decedent's estate which is subject to probate administration does not exceed Two Hundred Thousand Dollars (\$200,000), and thus the estate is subject to summary administration as provided in Chapter 145 of the Nevada Revised Statutes.

Good cause appearing

IT IS HEREBY ORDERED and DECREED that the Decedent's will is admitted to probate



1 and that Letters Testamentary for the Estate of ANN RUEF BOSTWICK shall be issued to
2 RONALD E. RUEF upon taking the oath of office.

3 IT IS FURTHER ORDERED that RONALD E. RUEF shall serve without bond.

4 IT IS FURTHER ORDERED that the estate shall be entitled to summary administration as
5 provided in Chapter 145 of the Nevada Revised Statutes, dispensing with all regular proceedings and
6 notices, except for the notice to creditors of the appointment of the Executor and notice of
7 application for attorney's fees and providing that an inventory, appraisalment and record of value be
8 made and returned to the Court.
