Howard, BENEFICIARY, whose address is 600 Gordon Ave. Reno, NV 89509 WITNESSETH: That Trustor grants to Trustee in trust, with power of sale, that property in the County of Douglas, State of NEVADA described as:

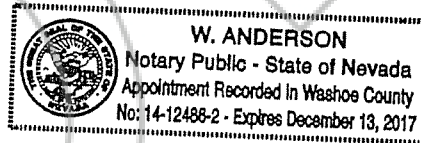
