CONTRACT AMENDMENT NO. <u>001</u>

Revised Scope of Work to complete Headworks Electrical Design for the North Valley WWTP

WHEREAS, on February 5, 2014, Douglas County, a political subdivision of the State of Nevada ("County"), and Resource Concepts, Inc., an independent contractor ("Contractor") (the "Parties"), entered into a contract for engineering services to complete plans and specifications for and assist in bidding a replacement screen at the North Valley Wastewater Treatment Plant, in an amount not to exceed \$8,000.00 ("Contract");

WHEREAS, the County desires to modify the Contract to have Contractor provide additional work. The additional work is to complete plans and specification for the replacement of existing electrical outlets, wiring, conduit, and new gas fired heating unit and exhaust fan within the existing screener room at the North Valley WWTP headworks to bring the electrical components in the room up to the most current electrical code (the "Additional Work"); and

WHEREAS, the Parties agree that Contractor shall perform the work on a time and material basis for a total cost not to exceed two thousand three hundred dollars (\$2,300) as consideration for the Additional Work.

NOW, THEREFORE, in consideration of the agreements herein made, the Parties mutually agree as follows:

- 1. The Contract sum will be increased by \$2,300.00, not to exceed a total contract amount of \$10,300.00.

- 3. All other terms and conditions of the original Contract remain unchanged and in full effect.
