#### LIMITED POWER OF ATTORNEY

## KNOW ALL PERSONS BY THESE PRESENTS:

THAT, BANK OF AMERICA, NATIONAL ASSOCIATION ("Seller"), by these presents does hereby make, constitute and appoint INDECOMM HOLDINGS INC. DBA INDECOMM GLOBAL SERVICES ("Indecomm"), by and through the individuals listed on Exhibit A hereto, Seller's true and lawful attorney-in-fact, and hereby grants it authority and power to take, through its duly authorized officers, the Actions (as such term is defined herein) in Seller's name, place and stead. This limited power of attorney ("Limited Power of Attorney") is given in connection with, and relates solely to, mortgage loans ("Loans") sold by Seller and certain of its affiliates to ALTISOURCE RESIDENTIAL, L.P. Except as provided herein, nothing contained herein shall be construed to grant Indecomm the power to (i) initiate or defend any suit, litigation, or proceeding in the name of Seller or be construed to create a duty of Seller to initiate or defend any suit, litigation, or proceeding in the name of Purchaser, or (ii) incur or agree to any liability or obligation in the name of or on behalf of Seller. This Limited Power of Attorney is entered into and shall be governed by the laws of the State of New York without regard to conflicts of law principles of such state.
