EXECUTOR'S DEED

THIS INDENTURE made the 16th day of September, 2014, by and between the Estate of Mary Alice Johnson, Deceased, by and through the Executor of the estate, Dawan R. Johnson ("Grantor") and Dawan R. Johnson, an individual ("Grantee"), and upon the following recitals, each of which is incorporated into the grant of a life estate by Grantor to Grantee, and for good and valuable consideration, the receipt of which is hereby acknowledged, Grantor and Grantee recite and agree as follows."

WHEREAS, pursuant to the Order of the Ninth Judicial District Court of the State of Nevada in and for the County of Douglas, In the Matter of the Estate of Mary Alice Johnson, Deceased; Case No. 14-PB-0039; assigned to Department 1 of the Ninth Judicial District Court, the Honorable Nathan Tod Young presiding, the Court did enter that Order Approving Verified Petition for First and Final

Accounting; Approving Actions of Personal Representative; Approving Attorney's Fees and Costs; Approving Reimbursement of Costs and Waiver of Ordinary Commissions; and Approving Distribution and Settlement ("Order") on the 16th day of September, 2014; and

WHEREAS, pursuant to the terms and provisions of the Order, the Court ratified, confirmed and approved of the Executor of the Decedent's estate executing an Executor's Deed conveying to Dawan R. Johnson a life estate in the Decedent's real property, described below, for the rest of his natural life for so long as Dawan R. Johnson does not remarry or cohabit in a marital-like relationship; that Dawan R. Johnson promptly pay all taxes and assessments of every kind that may be levied on the property; and that Dawan R. Johnson pay all debts and obligations incurred with respect to the property for the duration of the life estate; and

WHEREAS, the Order further ratified, confirmed and approved that, upon termination of the life estate granted to Dawan R. Johnson, the Decedent's real property and improvements would then be conveyed to Pamela Scott, Robert McDonald and Charlotte Conti, as tenants in common.
