## INDEMNITY AND HOLD HARMLESS AGREEMENT

This Indemnity Agreement is made by Francisco Javier Sanchez and Marisol Sanchez, hereinafter collectively referred to as "Indemnitor", owners of Francisco's Mexican Restaurant, as of the date written below, an agreement and pledge in favor of Douglas County, a political subdivision of the State of Nevada, herein referred to as "Indemnitee" on the terms set forth herein.
