DEFINITIONS

(A) **"Security Instrument"** means this document, which is dated September 24, 2014, together with all Riders to this document.


MASTER FORM DEED OF TRUST

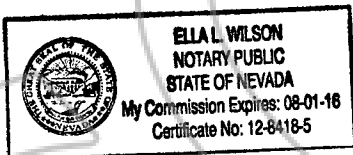
