ORDER APPROVING AND CONFIRMING FIRST AND FINAL ACCOUNT; ORDER APPROVING PAYMENT OF ADMINISTRATIVE FEES AND COSTS; AND ORDER FOR FINAL DISTRIBUTION

The Court having reviewed the First and Final Account and Report of Personal Representative; Petition for Confirmation; Application for Order Directing Payment of Administrative Fees and Costs; and Petition for Final Distribution, in which the Personal Representative requests an order approving and confirming its first and final account and report, payment of administrative fees and costs, and an order for final distribution, it appearing that notice of the hearing having been given according to law, this matter having been set for hearing on September 22, 2014, this matter having come before the Court for hearing on said date, the Court having examined the Personal Representative's papers, having considered the representations of counsel, and the entire file herein, and good cause appearing therefor, the Court finds:

- Ronald Craig Dougan died on March 1, 2013, in Clackamas County, Oregon, and left property in the State of Nevada subject to probate in this Court.
 - The Decedent's Last Will and Testament dated May 25, 1977 was 2.

admitted to probate in the Circuit Court of the State of Oregon, County of Clackamas in case number P1209034.

- 3. Letters Testamentary were issued to U.S. Bank on January 27, 2014.
- 4. On April 16, 2014, the Personal Representative filed the Inventory, Appraisement and Record of Value in this matter showing a net value of \$195,000 consisting of three parcels of unimproved real property.
- 5. A Notice to Creditors of the Decedent's estate was duly published according to law. Proof of publication is on file herein. No claims were filed against the Estate.
- 6. The Personal Representative did not receive any income and expended no sums during administration.
- 7. The Personal Representative rendered all services necessary as the personal representative of the Decedent's estate and is entitled to a commission. The commission will be paid by the domiciliary estate.
- 7. Woodburn and Wedge rendered all legal services as attorneys for the Personal Representative in this matter. At the commencement of this matter, the Personal Representative agreed that Woodburn and Wedge would charge its usual and customary hourly rates, plus actual costs incurred in this matter. The fee arrangement between the Personal Representative and Woodburn and Wedge and the fees requested in the amount of \$4,445.00 and reimbursement for costs incurred in the amount of \$923.84 should be approved, plus \$1,000.00 for closing fees and costs.
 - 8. This estate is in a condition to be closed and all assets to be distributed.
- 9. As this is an ancillary proceeding, the assets of this estate should be distributed to U.S. Bank, N.A., the personal Representative of the estate of Ronald Craig Dougan, deceased, Circuit Court of the State of Oregon, County of Clackamas, Case #P1309034, for distribution pursuant to the Decedent's Last Will and Testament.

Based on the foregoing findings of fact:

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

- 1. The First and Final Account and Report in the above matter is hereby settled, allowed, approved and confirmed.
- 2. The Personal Representative used reasonable diligence in his administration and all actions taken by the Personal Representative are hereby approved and confirmed.
- 3. The Personal Representative is authorized and directed to pay itself a commission in the amount of \$5,050.00.
- 4. The Personal Representative is authorized and directed to pay to Woodburn and Wedge the sum of \$4,445.00 and to reimburse Woodburn and Wedge for costs incurred in the sum of \$923.84, for a total of \$5,368.84.
- 5. The Personal Representative is authorized and directed to pay to Woodburn and Wedge the sum of \$1,000.00 for closing fees and costs.
- 6. The Personal Representative is authorized and directed to distribute all of the remaining assets in its custody and control and any other property of the Estate not now known or discovered that may belong to the Estate or in which the Estate may have any interest, including the following,
 - Vacant land located at 1579 Chiquita Drive, Minden,
 NV; APN 1420-34-811-022 and legally described as:
 - Lot 12, El Rancho Estates, Douglas County, Nevada, being a portion of SE ¼ of the SE ¼ of Section 34, Township 14 North, Range 20 East, M.D.B.&M (per NRS 111.312, this legal description was previously recorded as Document No. 39867, Book No. 1279, Page 1244, on December 20, 1979)
 - B. Vacant land located at 2613 Squires Drive Minden, NV; APN 1420-34-811-032 and legally described as:
 - Lot 2, El Rancho Estates, Douglas County, Nevada, being a portion of SE ¼ of the SE ¼ of Section 34, Township 14 North, Range 20 East, M.D.B.&M.
