As part of the topographic base mapping, Stantec plotted the US 395 right-of-way relative to found monuments based on right-of-way drawings from NDOT in support of encroachment permitting. Our understanding is that you would now like us to perform additional research and mapping in order to determine if the proposed improvements are within the existing rights-of-way of Waterloo Lane and US 395.
