## GRANT DEED

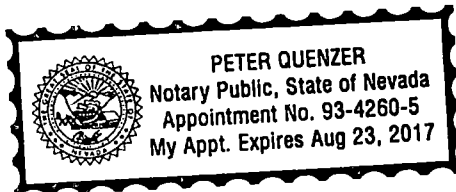
