5. The Judgment has been partially satisfied in the amount of \$2,379.09.


6. Post-Judgment interest has accrued at the legal interest rate, and the unpaid judgment balance is \$7,809.31.

8. The exact amount due on the Judgment as of October 21, 2014, is \$7,809.31.


