THIS DEED UPON LIEN FORECLOSURE is made this November 13, 2014, by The Ridge Tahoe Property Owners' Association, a Nevada non-profit corporation, herein Grantor, having the address of P.O. 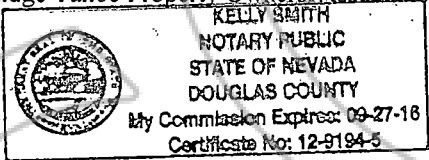
