### STATUTORY FORM POWER OF ATTORNEY

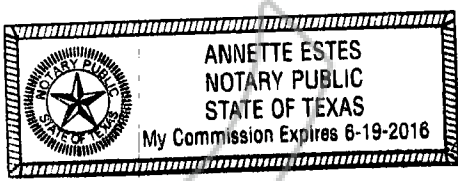

LEGAL DESCRIPTION**
