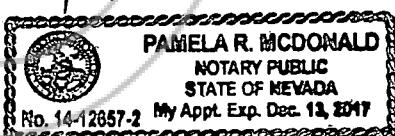

24 After considering all of the evidence, the Master hereby makes the following Findings and
25 Recommendations:

26 The Obligee and Obligor were mailed by regular mail, on NOVEMBER 21, 2014, a
27 NOTICE OF HEARING.

1 () Obligor was properly served and noticed of today's hearing at his/her last known
2 address and failed to appear.

3 (X) Obligee was properly noticed of today's hearing on or about November 21, 2014
4 Obligor is the parent of the following child:

6 JONOTHAN RICHARD EUGENE HUNIKER

APRIL 30, 2002

7 (X) Based on the Obligor's incarceration the gross monthly earnings are \$0. Pursuant to the
8 formula prescribed within NRS 125B.070, 18% of those earnings are \$0.

9 (X) The Child support amount recommended by the Court Master (set out in paragraph 4
10 below) deviates from the statutory percentage because under NRS 125B.080, the
11 following factors were considered: State statutory
12 minimum applies.

13 THE RECOMMENDED ORDER:

14 1. (X) Ongoing support is ordered in the amount of \$ 100.00 per month beginning first
15 month following Obligor's release from custody. The obligation for Child Support
16 continues until the child turns 18 years of age, or until the child turns 19 years of age if
17 the child is enrolled in High School. However, this obligation to support a child is
18 affected by a child's ability to live on their own (NRS129.080 to 129.140 – legal
19 emancipation) or when applicable, continued financial support beyond the age of
20 majority per NRS125B.110.

21 2. (X) The Obligor is responsible for **child support** arrears for the period of
22 February 1, 2011 through November 30, 2014.

23 (X) A judgment is entered against the Obligor for **child support** arrears as follows:

1 (✓) Principal in the amount of \$ 5,306.99

2 (✓) Interest in the amount of \$ 137.93

3 (✓) Penalty in the amount of \$ 370.00

4 For a total judgment of \$ 5,814.92 to be repaid at \$ 35.00 per month

5 beginning first month following Obligor's release from custody.

6 All payments MUST be made in the form of a money order, cashier's check or business check

- 16 D. Name of custodian (first and last name of person receiving child support).

17 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING
18 OF GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE
19 WILL NOT FULFILL THE OBLIGATION.**

20 **NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY TO
21 THE OBLIGEE.**

- 22 3. All payments shall be made by immediate income withholding. If you pay your child
23 support through income withholding and your full obligation is not met by the amount
24 withheld by your employer, you are responsible to pay the difference between your
25 court ordered obligation and the amount withheld by your employer directly to the
26 STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU). If you fail to do so
27 you will be subject to the assessment of penalties and interest. You may avoid these
28 additional costs by making your current child support payments each month.

- 1 4. (X) The Obligee shall provide health insurance coverage for the child when available
2 through employment or group policy under a plan that is reasonable in cost as defined
3 in NRS 125B.085 and Obligor shall pay \$ 28.00 per month for health insurance
4 premium (medical cash) effective first month following Obligor's release from custody.
5 Medical costs incurred for the above-referenced period have not yet been determined.
6 The State's right to recover said costs is not waived by way of this order.
- 7 5. (X) Pursuant to NRS 125B.080(7), expenses for health care which are not reimbursed
8 through insurance, including expenses for medical, surgical, dental, orthodontic and
9 optical expenses, must be shared equally by both parents.
- 10 6. Except as modified herein the terms, conditions and obligations set forth in prior orders
11 shall remain in full force and effect.
- 12 7. The Obligor shall keep Division of Welfare and Supportive Services informed of any
13 change regarding current employment and of access to health insurance coverage in
14 WRITING (including health insurance policy information) within 10 days of such.
15 8. Obligor shall be responsible for ALL child support and judgment payments due.
16 Payment is to be made directly to the STATE COLLECTION AND
17 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor
18 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT
19 UNIT (SCaDU).
- 20 9. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
21 (including payment in lieu of medical insurance) and spousal support balances, for
22 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
23 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
24 shall accrue at the rate established by NRS 125B.140(2)(c)(1).
- 25 10. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid
26 monthly child support amount will be added to the arrears balance of the Obligor if the
27 Obligor becomes delinquent in the amount owed for one month's support.

- 1 11. All payment collections shall be held in abeyance until the first day of the first
2 month following the release of Obligor from incarceration; re-employment, or if assets
3 become available.
- 4 12. The State of Nevada has continuing exclusive jurisdiction for enforcement and
5 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
6 Act.

7 It is further ordered that: See page 2; lines 10-13.

8 Obligations and interest will not
9 accrue during periods of incarceration.
