## AFFIDAVIT - DEATH OF TRUSTEE

The undersigned, of legal age, being first duly sworn, deposes and says:

- 1. William L. Fariester and Eileen E. Fariester, as Trustors, have heretofore entered into a Declaration of Trust dated November 16, 1994, pursuant to which The Fariester Family Trust was established. This Trust has never been recorded in any County Recorder's Office.
- Pursuant to the terms of the Declaration of Trust, William L. Fariester and Eileen E. Fariester were named as the original Trustees.
- 3. The Declaration of Trust provides that, upon the death of William L. Fariester, Eileen E. Fariester shall act as successor Trustee of all trusts created pursuant to the Declaration of Trust.
- 4. William L. Fariester became deceased on June 7, 2001, as evidenced by a certified copy of his Certificate of Death which is attached hereto and incorporated herein by reference.
- 5. William L. Fariester, identified as the decedent in the attached certified copy of Certificate of Death, is the same person named as one of the parties in that certain Warranty Deed dated December 12, 1994, executed by William L. Fariester and Eileen E. Fariester to William L. Fariester and Eileen E. Fariester, Trustees of the Fariester Family Trust, dated November 16, 1994, and recorded March 6, 1995, as Document No. 357380 in Book 395, Page 0636, in the Official Records of Douglas County, Nevada, regarding an interest in real property located in Douglas County, Nevada, more fully described as follows:

#### Parcel One:

An undivided 1/51st interest in and to that certain condominium described as follows:
