SUBORDINATION AGREEMENT

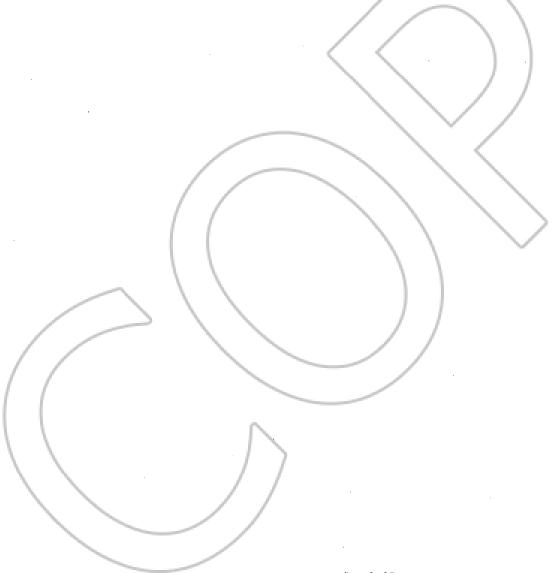
