6. There are no setoffs or counterclaims in favor of the Judgment Debtor.


7. There has not been any payments on the Judgment;

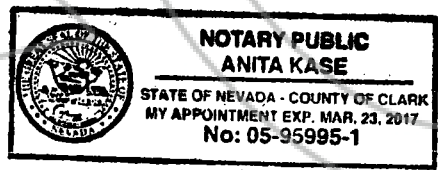


