#### DEFINITIONS

(A) "**Security Instrument**" means this document, which is dated April 07, 2015, together with all Riders to this document.

(B) "**Borrower**" is PAUL E. SANDBERG AND RENAE SANDBERG, AS TRUSTEES OF THE SANDBERG REVOCABLE TRUST. Borrower is the trustor under this Security Instrument.

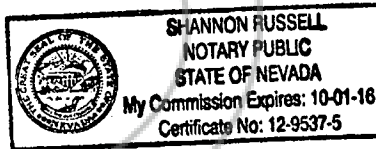

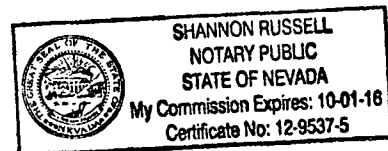


