This is NOTICE that the living man Frank A. Bilan, hereinafter your Affiant, hereby terminates his uninformed election to be treated as a resident alien or taxpayer pursuant to the statutory will of Congress. [cf. IRC §6013(g)(4)(A)]

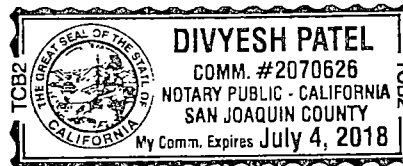

Affiant also gives NOTICE of MISTAKE that Affiant made an uninformed election under IRC §6013(g) to be treated as a District of Columbia Resident Alien.

1. Your Affiant, Frank A. Bilan, is a man with a soul who is over the age of majority, NOT civilly dead and is competent to state the facts herein. [cf. Congressional Record, June 13, 1967, pp. 15641-15646]
2. Your Affiant hereby gives NOTICE that Affiant reserves his right, at arm's length, not to be compelled to perform under any contract, commercial agreement or implied trust relationship that Affiant did not enter knowingly, voluntarily and intentionally. Affiant transacts at arm's length with "this State" and does not accept the liability or duty of the compelled benefit of any unrevealed contract, commercial agreement or implied trust relationship.
3. Your Affiant hereby gives NOTICE that Affiant only references the United States Code and regulations by necessity for clarity of purpose in this document and to identify the duties of all government corporate actors.
4. Your Affiant hereby declares that the civilly dead United States created entity, FRANK A. BILAN with the associated green card is insolvent.
5. Your Affiant denies that Affiant ever knowingly and voluntarily assumed the servitude of resident agent or fiduciary duty for any civilly dead United States created statutory entity or franchise, FRANK A. BILAN.

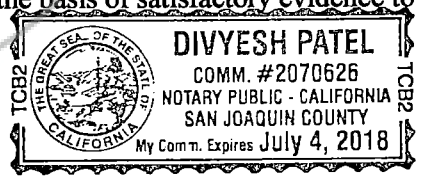
