SUBORDINATION AGREEMENT

This Subordination Agreement ("Agreement") is made this Eleventh day of May, 2015, by Bank of America, N.A., ("Subordinating Lender"), a corporation whose address is 101 South Tryon Street, Charlotte, NC 28255.

WITNESSETH:

WHEREAS, Subordinator is the beneficiary/mortgagee of that certain Deed of Trust/Mortgage ("Security Document") pursuant to that certain Security Document dated 05/24/2007 (the "Senior Lien"), and executed by TRISTAN GERRA and CHRISTINE GERRA AKA CHRISTINNE GERRA (together, the "Owner") and encumbering that certain real property located at 220 CANYON C, ZEPHYR COVE, NV 89448 (address) which is legally described on <a href="Exhibit "A" attached hereto and incorporated herein (the "Property"), which Security Document was recorded on 06/08/2007 in Official Records Book NA, Page NA, as Instrument No. 702648, of the Official Records of Douglas County, NV, as the same may have been or is to be modified prior hereto or contemporaneously herewith.

WHEREAS, Bank of America, N.A. - (3) This Agreement is limited to the Principal Amount, plus interest and any additional amounts advanced pursuant to the provision of the Note or Junior Lien for payment of insurance premiums, taxes, cost of collection or protection of the value of the Property or Junior Lien Holder's rights in the Property. This Agreement shall inure to the benefit of Junior Lien Holder and be binding upon Subordinator, its successors and assigns and shall be binding upon any purchaser (at foreclosure or otherwise) of the Property, or any part thereof, and their respective heirs, personal representatives, successors and assigns.
