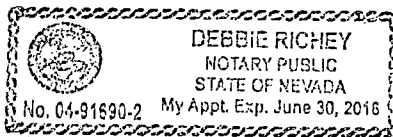

25 After considering all of the evidence, the Master hereby makes the following Findings and
26 Recommendations:

27 The Obligor was properly served on FEBRUARY 13, 2015, with a Notice and Finding of
28 Financial and Responsibility.

1 Obligor is the father/parent of ASHTON HENRY MORA, born NOVEMBER 27, 2009.

2 Obligor was properly served and noticed of today's hearing at his/her last known
3 address and failed to appear.

4 () Obligee was properly noticed of today's hearing on or about

5 () Based on the Obligor's incarceration the gross monthly earnings are \$0. Pursuant to the
6 formula prescribed within NRS 125B.070, 18% of those earnings are \$0.

7 () The Child support amount recommended by the Court Master (set out in paragraph 4
8 below) deviates from the statutory percentage because under NRS 125B.080, the
9 following factors were considered: _____

13 THE RECOMMENDED ORDER:

14 1. () The Obligor shall pay \$ _____ per month in ongoing support beginning
15 _____ . The obligation for Child Support continues until the
16 child turns 18 years of age, or until the child turns 19 years of age if the child is
17 enrolled in High School. However, this obligation to support a child is affected by a
18 child's ability to live on their own (NRS129.080 to 129.140 – legal emancipation) or
19 when applicable, continued financial support beyond the age of majority per
20 NRS125B.110.

21 2. An arrears Judgment is entered in the amount of \$ 1000.00 for/through
22 March 1, 2011 through April 30, 2015.

23 To be paid by payments of \$ 25.00 per month beginning May 1, 2015.

24 All payments MUST be made in the form of a money order, cashier's check or business
25 check and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)**
26 and sent to:

- 1 6. The Obligor shall keep Division of Welfare and Supportive Services informed of any
2 change regarding current employment and of access to health insurance coverage in
3 **WRITING** (including health insurance policy information) within 10 days of such
4 change.
- 5 7. Obligor shall be responsible for ALL child support and judgment payments due.
6 Payment is to be made directly to the STATE COLLECTION AND DISBURSEMENT
7 UNIT (SCaDU). At any time withholding does not occur, Obligor must make
8 voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT
9 (SCaDU).
- 10 8. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
11 (including payment in lieu of medical insurance) and spousal support balances, for
12 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
13 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
14 shall accrue at the rate established by NRS 125B.140(2)(c)(1).
- 15 9. Pursuant to NRS125B.095, a late fee/penalty of 10% (ten percent) of the unpaid
16 monthly child support amount will be added to the arrears balance of the Obligor if the
17 Obligor becomes delinquent in the amount owed for one month's support.
- 18 10. (X) All payment collections shall be held in abeyance until the first day of the first
19 month following Obligor's release from incarceration, employment, or if assets become
20 available.
- 21 11. The State of Nevada has continuing exclusive jurisdiction for enforcement and
22 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
23 Act.

24 It is further ordered that: Obligee has waived all arrears
25 owed to her from March 1, 2011 through
26 April 30, 2015. Obligee is requesting closure
27 of her portion of the case. Case is arrears
28 only. Interest waived during periods of
Incarceration.


