7 7. There has not been any payments on the Judgment;

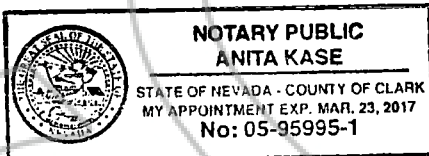
8 8. The total judgment as of May 8, 2015 is \$22,543.03, inclusive of all costs and fees, along


