This Interlocal Agreement for small business counseling is made and entered into between Carson City, a consolidated municipality and political subdivision of the State of Nevada (hereinafter referred to as "Carson"), and Douglas County, a political subdivision of the State of Nevada (hereinafter referred to as "Douglas") based upon the mutual promises and representations contained herein.

RECITALS

WHEREAS, Nevada Revised Statutes 277.180(1) allows any one or more public agencies to make an agreement with any one or more other public agencies to perform any governmental service, activity or undertaking which any of the public agencies entering into the agreement is authorized by law to perform; and

WHEREAS, Douglas County no longer benefits from small business counseling within a close proximity due to the Nevada Small Business Development Center ("NSBDC") program being reduced in the University of Nevada budget; and

WHEREAS, there is a need to provide this service in Douglas to foster economic development; and

WHEREAS, Carson City has hired a Business Development Manager to provide the services that were previously provided by NSBDC; and

WHEREAS, Carson is willing to provide small business counseling services to Douglas for \$5000 per year; and,

WHEREAS, Douglas is desirous of entering into an agreement with Carson for those services; and

NOW, THEREFORE, in consideration of the promises and of the mutual covenants herein contained, it is agreed among the parties as follows:

1. Carson will provide small business counseling to people or companies who desire to begin a business in Douglas County. The counseling will be through Carson's City Manager's office. The term of this agreement is from June 1, 2015 to May 31, 2016, and may be extended for successive one-year periods provided both parties agree in writing. If extended, all terms and conditions shall apply but the costs may be re-negotiated.

- 2. Douglas will pay Carson a sum total of \$5,000 annually for this service. The total amount shall be paid on or before June 30th of each year unless this agreement is terminated. Carson will not refund any portion of the amount paid unless the service is terminated by July 30.
- 3. Carson agrees that in providing this service, to not allow information gained from those who may be doing, or wanting to do, business in Douglas be divulged to other competing interests without permission of the County Manager. In the event of a breach of this provision, Douglas County may immediately withdraw, without penalty or payment, from this Contract.
