### GRANT DEED

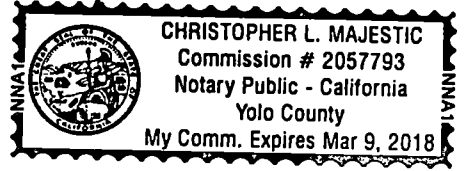
