GRANT DEED

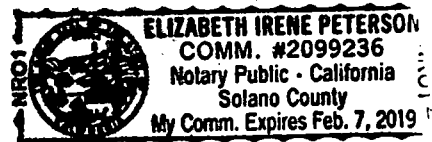
