DEFINITIONS

(A) "Security Instrument" means this document, which is dated July 16, 2015, together with all Riders to this document.



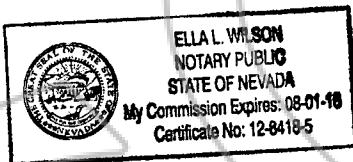
