DEFINITIONS

Words used in multiple sections of this document are defined below. The Master Form Deed of Trust includes other defined words and rules regarding the usage of words used in this document.

- (A) **"Security Instrument"** means this document, which is dated July 20, 2015, together with all Riders to this document.
- (B) **"Borrower"** is WILLIAM W. FREIXAS AND JANET M. FREIXAS, HUSBAND AND WIFE, AS JOINT TENANTS WITH RIGHT OF SURVIVORSHIP AND NOT AS TENANTS IN COMMON. Borrower is the trustor under this Security Instrument.



MASTER FORM DEED OF TRUST




