12 Based upon the Stipulation for Settlement of All Claims and Dismissal Without Prejudice between
13 Petitioner, DOUGLAS KIDSTON BOURNE (hereinafter "BOURNE"), as Beneficiary of the S.H.
14 Bourne 1994 Trust and Beneficiary of the Douglas Kidston Bourne Trust (hereinafter the "DKB
15 TRUST"), by and through his attorney, MAXWELL B. GLASSON, ESQ., of Alling & Jillson, Ltd., and
16 Petitioner SHERI L. BOURNE-AVIS (hereinafter "AVIS"), Successor Trustee of the S.H. Bourne 1994
17 Trust (hereinafter the "TRUST"), by and through her attorney, THOMAS J. HALL, ESQ., the Parties to
18 this action, and good cause appearing therefore,

19 IT IS HEREBY ORDERED that the Stipulation for Settlement of All Claims and Dismissal
20 Without Prejudice (the "STIPULATION") filed with this Court by the Parties to it is adopted as the Order
21 of this Court as follows:

22 1. The principal amount owed from the TRUST, to be distributed by AVIS to the DKB
23 TRUST, pursuant to Section 5.02 of the TRUST, is One Million Three Hundred Thousand and no/100
24 Dollars (\$1,300,000.00) (the "OBLIGATION").

25 2. Any outstanding principal of the OBLIGATION has accrued and shall continue to accrue
26 interest at five and one-quarter percent (5.25%) from November 12, 2013, six months after the date of
27 death of Stephen H. Bourne on May 12, 2013, until paid in full.

1 3. Any payment of the OBLIGATION received by the DKB TRUST shall be applied first
2 to interest accrued, then to the principal balance of the OBLIGATION still outstanding.


3 4. All prior payments of the OBLIGATION to the DKB TRUST shall be applied to principal
4 and interest accrued on the OBLIGATION as set forth on the accounting attached as Exhibit 1 to the
5 STIPULATION.

6 5. The Filings made by BOURNE, as defined in the STIPULATION, shall be dismissed
7 without prejudice.


8 6. The Petition filed by AVIS, as defined in the STIPULATION, shall be dismissed without
9 prejudice.


10 7. Each party shall bear their own fees and costs herein.

11 8. The Court shall retain jurisdiction to enforce the payment of the amounts of the
12 OBLIGATION due to the DKB TRUST, to monitor the funding of the OBLIGATION, and to make sure
13 the funding of OBLIGATION shall take place.
