(A) **"Security Instrument"** means this document, which is dated August 29, 2015, together with all Riders to this document.

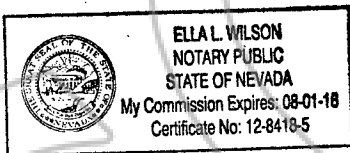

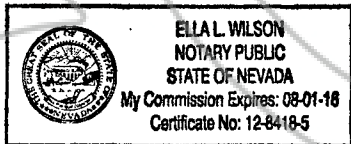
