(A) "Security Instrument" means this document, which is dated August 29, 2015, together with all Riders to this document.

(B) "Borrower" is RICKY PAUL DECARLO AND CYNTHIA C. DECARLO, TRUSTEES OF THE C & R DECARLO 1993 TRUST DATED JULY 22, 1993. Borrower is the trustor under this Security Instrument.






