

This DECLARATION OF TRUST is entered into on the date hereinafter designated by Eris M. Hirdler, Trustor, and Eris M. Hirdler, Trustee, in order to establish a trust for the purposes and under the terms and conditions hereinafter set forth.

The Trustor declares that she is unmarried, having at one time been married to Richard D. Hirdler who died in October of 1995, leaving her a widow.

The Trustor declares that she has four (4) children, namely: Paul Richard Hirdler (Paul), born April 19, 1948; David William Hirdler (David), born June 9, 1950; Diana Jane Cordova (Diana), born June 9, 1952; and John Thomas Hirdler (John), born October 12, 1954, and no others living or dead.

The Trust created by this instrument may be referred to as the ERIS M. HIRDLER 1996 TRUST.

The Trustor has conveyed, transferred, assigned and delivered to the Trustee, without consideration, the property described in Schedule A attached hereto and made a part hereof, which property and any other property hereafter transferred to this trust is designated hereafter as the "Trust Estate."

ARTICLE I

RIGHTS RESERVED BY TRUSTOR

The Trustor specifically reserve the following rights and privileges:

A. Right to Add Property to the Trust

The Trustor, or any other person with the consent of the Trustor, may add further property to the Trust Estate or any part thereof, by deed, assignment, bequest or devise, and if so added, such property shall be subject to the provisions hereof the same as if originally included hereunder.

B. Right to Revoke or Amend Trust

- (1) The Trustor may at any time or times revoke this Trust in whole or in part, alter or amend any of its provisions, or withdraw all of any part of the Trust Estate; however, the duties and responsibilities of the Trustee may not be substantially changed without the Trustor's written consent.
- (2) If the Trustor is incompetent, the power to revoke or amend may not be exercised by any successor Trustee or agent acting under any form of a power of attorney.

- (5) any other person unanimously designated in writing as successor Trustee by all adult competent beneficiaries then or in the future entitled to a distribution from this trust and the trust estate created hereunder (and in the absence of such designation, then as designated by a court of competent jurisdiction). Incapacity or unwillingness or any individual to serve as (or designate) a Trustee or Co-Trustee may be evidenced by (i) a written declination to act, or (ii) a court order appointing a conservator for the individual, or (iii) a certified copy of the individual's death certificate, or (iv) a certificate of one licensed physician as to the individual's incapacity to act.

D. Status and Responsibility of Successor Trustee

Any Successor Trustee shall succeed to all title to the property of the Trust Estate, and all the powers, rights, discretion, obligations and immunities of the Trust hereunder with the same effect as though such successor had originally been named Trustee.
