LIMITED POWER OF ATTORNEY

KNOW ALL PERSONS BY THESE PRESENTS, that the FEDERAL DEPOSIT INSURANCE CORPORATION, a corporation organized and existing under an Act of Congress, hereafter called the "FDIC", hereby designates the employees(s) of Sabadell United Bank, Miami, Florida set out below (the "Attorney(s)-in-Fact") for the sole purpose of executing the documents outlined below:
