#### DEFINITIONS

(A) "Security Instrument" means this document, which is dated October 16, 2015, together with all Riders to this document.

(B) "Borrower" is LAUREN L. SAUNDERS, AN UNMARRIED WOMAN AND ROBERT W. ALBRECQ, AN UNMARRIED MAN, AS JOINT TENANTS WITH RIGHT OF SURVIVORSHIP. Borrower is the trustor under this Security Instrument.

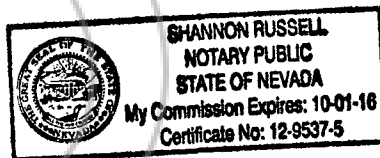
