#### DEFINITIONS

(A) **"Security Instrument"** means this document, which is dated October 15, 2015, together with all Riders to this document.

(B) **"Borrower"** is JAMES M. WILEY AND SALLY D. WILEY, HUSBAND AND WIFE, AS JOINT TENANTS WITH RIGHT OF SURVIVORSHIP. Borrower is the trustor under this Security Instrument.



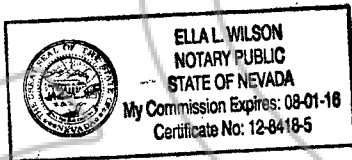
