#### DEFINITIONS

(A) **"Security Instrument"** means this document, which is dated November 18, 2015, together with all Riders to this document.

(B) **"Borrower"** is DERRICK CARPENTER AND KALLIE A. CARPENTER, HUSBAND AND WIFE, AS JOINT TENANTS. Borrower is the trustor under this Security Instrument.

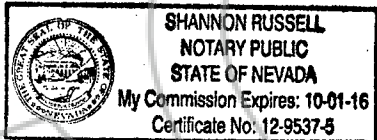
