17 Support to Prove Up on Judgment, the Defendants Terri Dickerson and Chris Dickerson having
18 been duly served with Summons and process herein as provided by law, and default having been
19 regularly entered against said Defendants upon the Complaint of the plaintiff and all the records
20 and files herein, and Plaintiff, by said Declaration, having presented evidence in support of the
21 allegations of its Complaint, said Defendants presenting no evidence, and the Court being fully
22 advised in the premises, and the Court finding that there is now due and owing from the
23 Defendants Terri Dickerson and Chris Dickerson, jointly and severally, to the Plaintiff the sum of
24 \$20,230.40 principal together with prejudgment interest thereon at the rate of 10% per annum
25 from July 1, 2010 to November 23, 2015, in the sum of \$10,970.00 and that the sum of \$975.00
26 is a reasonable attorney's fee to be allowed the Plaintiff in connection with this action; and that
27 each and every allegation in Plaintiff's Complaint was and is true, and that the Plaintiff is entitled
28 to the relief prayed for in said Complaint, the Court decides in favor of the Plaintiff and against

1 the Defendants.

2 IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Plaintiff have and
3 recover judgment from the Defendants TERRI DICKERSON and CHRIS DICKERSON, jointly
4 and severally, in the sum of \$31,200.40, together with interest thereon at 10% per annum,
5 hereafter until paid, attorney's fees of \$975.00, and costs herein incurred in the sum of \$486.50.


