Karafa Living Trust, dated January 15, 2015, and any amendments thereto, 1644 Tony Court, Monroe, MI 48162 (hereinafter called "Grantee"), does hereby bargain, quitclaim, transfer and convey unto said Grantee and unto its successors and assigns forever, all of the right, title and interest owned, claimed or held by the Grantor in and to the following described real property located in Douglas County, Nevada and more particularly described as follows:

SUBJECT TO:


1. Any and all rights of way, reservations, restrictions, easements, mineral exceptions and reservations and conditions of record;


