NOTICE OF SATISFACTION AND PARTIAL RELEASE OF NOTICE OF LIEN



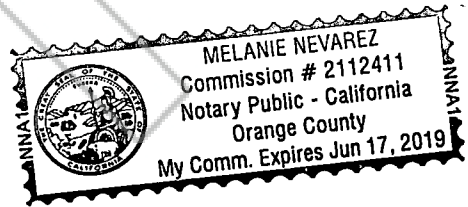
