GRANT OF EASEMENT

DESCRIPTION OF EASEMENT

An easement is granted to MGSD for access to a sewer line that serves a new residence located at 1280 Centerville Lane, APN 1220-04-002-004.

The easement is granted based on a plot plan dated June 10, 2013.

Building permit #45387 was issued by Douglas County Community Development on Oct. 9, 2013 for construction of the single family residence.

The easement is granted to MGSD or its contractors for access across parcel 1220-04-002-004 for the purpose of performing maintenance, repair, or improvements to the sewer line as required by MGSD. No additional access beyond the boundaries of the easement shall be permitted except as allowed by the property owner(s).

The easement shall be 20 feet wide, the centerline of which is beginning at a point on the west boundary 15 feet from the northwest property corner. It will extend a distance of 40 feet southeast to 30 feet from a manhole located in the northwest corner of the parcel.
