- Obligor shall be responsible for ALL child support and judgment payments due. 9. Payment is to be made directly to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU).
- Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances 10.
