An Order of Abandonment vacating a strip of land ten (10) feet in width for public utility easement for Continental Telephone Company located within one parcel, APN1318-16-801-003, on a portion of the Southeast one-quarter (SE ½) of the South half (S ½) of Section 16, Township 13 North, Range 18 East, MDB&M, Douglas County, Nevada. WHEREAS, This abandonment request is being made to remove an easement that runs in the center of the parcel and turns north to run parallel to the Lake Tahoe shoreline and as such would inhibit the proposed redevelopment of the parcel; and

WHEREAS, The Community Development Department has obtained written approval from the applicable public utility service provider indicating they no longer request the reservation of the subject easement; and

WHEREAS, On Telephone 29, 2014 the Douglas County Community Development Department Director determined that the aforesaid easements are no longer necessary or useful to Douglas County and that the public will not be materially injured by the vacation; and

NOW THEREFORE, be it ordered by the Douglas County Community Development Director, that the aforesaid strip of land 10 feet wide for utility easement purposes and incidents thereto, as described and depicted in the attached Legal Description and Exhibit A, are hereby abandoned.
