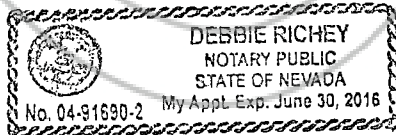

18 This matter was heard on FEBRUARY 12, 2016. The Court Master with the following
19 persons was present:

24 After considering all of the evidence, the Master hereby makes the following Findings and
25 Recommendations:

26 The Obligor was properly served on SEPTEMBER 2, 2015, with a Notice and Finding of
27 Financial and Parental Responsibility.

28 Oblige has named Obligor, ROBERT GENE STROUP, as the father of RILEY MORRIS,
born SEPTEMBER 23, 2013.

1 Obligor's gross monthly earnings are \$2,600.00. Pursuant to the formula prescribed
2 within NRS 125B.070, 18% of those earnings, the state calculates a support obligation
3 in the sum of \$468.00. Gross monthly income based on Obligor's testimony.

4 RECOMMENDED ORDER IS:

5 1. The Obligor is the parent of the following child:

6 NAME D.O.B.
7 RILEY MORRIS SEPTEMBER 23, 2013

8 2. That said child's birth certificate be amended by entering the name of ROBERT
9 GENE STROUP as the father of said child and that the Court order the state registrar of
10 vital statistics to prepare an amended certificate of birth consistent with this order.

11 3. The Obligor shall pay \$468.00 per month in ongoing support beginning MARCH 1,
12 2016. The obligation for Child Support continues until the child turns 18 years of age,
13 or until the child turns 19 years of age if the child is enrolled in High School. However,
14 this obligation to support a child is affected by a child's ability to live on their own
15 (NRS129.080 to 129.140 – legal emancipation) or when applicable, continued financial
16 support beyond the age of majority per NRS 125B.110.

17 4. An arrears Judgment is entered in the amount of \$4,297.00 for AUGUST 1, 2013
18 through FEBRUARY 29, 2016.

19 To be paid by payments of \$30.00 per month beginning MARCH 1, 2016.

20 All payments MUST be made in the form of a money order, cashier's check or business check
21 and payable to STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU) and sent
22 to:

25 The following information must be included with each payment:

- 26 A. Name (first, middle, last) of person responsible for paying child support.
27 B. Social Security Number of person responsible for paying child support.
28 C. Child support case number 347-87-2100B listed on each payment.
D. Name of custodian (first and last name of person receiving child support).

1 PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF
2 GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL
3 NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR
4 PAYMENTS PAID DIRECTLY TO THE OBLIGEE.

5 5. All payments shall be made by immediate income withholding. If your full obligation
6 is not met by the amount withheld by your employer, you are responsible to pay the
7 difference between your court ordered obligation and the amount withheld by your
8 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT
9 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and
10 interest. You may avoid these additional costs by making your current child support
11 payments each month.

12 6. The Obligee shall provide health insurance coverage for the child when available
13 through employment or group policy under a plan that is reasonable in cost as defined
14 in NRS 125B.085 and Obligor shall pay \$10.00 per month for health insurance
15 premium (medical cash) effective MARCH 1, 2016. Medical costs incurred for the
16 above-referenced period have not yet been determined. The State's rights to recover
17 said costs are not waived by way of this order.

18 7. Pursuant to NRS 125B.080(7), expenses for health care which are not reimbursed
19 through insurance, including expenses for medical, surgical, dental, orthodontic and
20 optical expenses, must be shared equally by both parents.

21 8. The Obligor shall pay and judgment is entered in favor of the Division of Welfare
22 Supportive Services for the reimbursement of genetic test fees totaling \$39.00, to be
23 paid by payments of \$10.00 per month beginning MARCH 1, 2016.

24 9. The Obligor shall keep the Division of Welfare and Supportive Services informed of
25 any change regarding current residential and/or mailing address, employment and of
26 access to health insurance coverage in WRITING (including health insurance policy
27 information) within 10 days of such change.

1 10. Obligor shall be responsible for ALL child support and judgment payments due.
2 Payment is to be made directly to the STATE COLLECTION AND
3 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor
4 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT
5 UNIT (SCaDU).

6 11. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
7 (including payment in lieu of medical insurance) and spousal support balances, for
8 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
9 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
10 shall accrue at the rate established by NRS 125B.140(2)(c)(1).

11 12. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid
12 monthly child support amount will be added to the arrears balance of the Obligor if the
13 Obligor becomes delinquent in the amount owed for one month's support.

14 13. The State of Nevada has continuing exclusive jurisdiction for enforcement and
15 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
16 Act.
