(A) **"Security Instrument"** means this document, which is dated March 18, 2016, together with all Riders to this document.

(B) **"Borrower"** is JOSEPH V. PAPERIO AND LINDA J. PAPERIO, TRUSTEES OF THE PAPERIO LIVING TRUST DATED JULY 8, 2014. Borrower is the trustor under this Security Instrument.

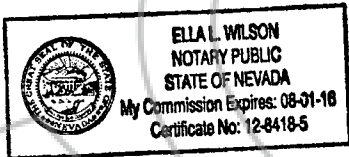

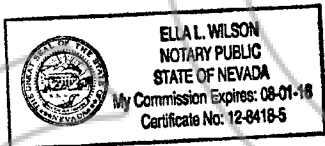
