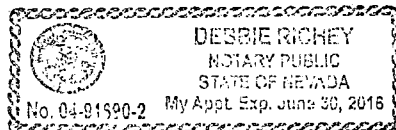

16 *The undersigned does hereby affirm this document does not contain the social security number
17 of any person, pursuant to NRS 239B.030.*

18 The parties having been advised and hereby stipulate to the entry and order as follows:

- 19 1. Obligor was ordered to pay \$257.00 per month in ongoing child support on AUGUST
20 8, 2012 for child ERIC LEE ELLISON born JUNE 20, 1997 (emancipated).
- 21 2. Obligor, LUKE ERNEST ELLISON, owes back child support to the Obligee SARAH
22 ELIZABETH JOHNSON, in the amount of \$24,357.33 in principal, \$14,297.19 in
23 interest, \$2,131.71 in penalty for a total of \$40,786.23 (see Exhibit 1) through and
24 including JANUARY 31, 2016. Obligor, LUKE ERNEST ELLISON, owes back
25 medical cash arrears in the amount of \$513.00 in principal, \$97.84 in interest, \$61.60
in penalty for a total of \$672.44 (see Exhibit 2).

- 1 3. Obligee, SARAH ELIZABETH JOHNSON, has agreed to accept a lump sum
2 payment in the amount of \$20,000.00 to satisfy both the child support arrears and
3 medical cash arrears owed to her. The Obligee agrees to waive child support arrears
4 and medical cash arrears in the amount of \$21,458.67.
- 5 4. So long as the lump sum payment is made to State Collection and Disbursement Unit
6 (SCaDU) within sixty (60) days from the date this stipulation is filed, said payment
7 will satisfy the arrears owed to SARAH ELIZABETH JOHNSON, through
8 JANUARY 31, 2016.
- 9 5. If the lump sum payment is not received within sixty (60) days of the filing date of
10 stipulation, the agreement is be null and void.
- 11 6. Obligor shall be responsible for ALL child support and/or judgment payments due.

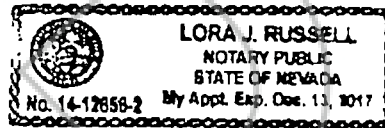

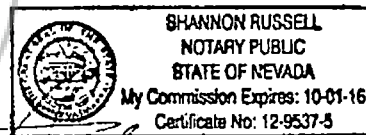
