A strip of land being an abandonment of a portion of an existing 5 foot wide public utility easement across a portion of Parcel 1 as shown on the Parcel Map recorded at Document no. 124005 in the office of the Douglas County Recorder, said abandonment lying entirely within the Southeast One-Quarter of Section 15, Township 12 North, Range 19 East of the Mount Diablo Meridian, Douglas County, Nevada, and being more particularly described as follows:

Commencing at the SW corner of said SE ¼ of Section 15, being a brass cap monument; Thence N 89°57'30"E along the South line of said Section 15 a distance of 1310.44 feet; Thence N 00°05'03"E a distance of 5.00 feet to the POINT OF BEGINNING; Thence S 89°57'30"W a distance of 5.00 feet;

Thence N 00°05'03"E a distance of 1,068.82 feet to a point on the Northwesterly boundary line of said Parcel 1;

Thence N 77°10'31"E along said Northwesterly boundary line a distance of 5.13 feet to the NE corner of said Parcel 1, being a 5/8 inch rebar with plastic cap bearing the PLS no. 3922; Thence S 00°05'03"W a distance of 1,069.95 feet to the POINT OF BEGINNING;
