THAT Coastline Holdings, LLC., (hereinafter called "Grantors"), for and in consideration of the sum of Ten Dollars (\$10.00) in hand paid by Wyndham Vacation Resorts, Inc., a Delaware Corporation (hereinafter called "Grantee"), whose address is 6277 Sea Harbor Drive, Orlando, FL 32821, does hereby bargain, sell, transfer and convey unto said Grantee, unto its successors and assigns forever, all of the right, title and interest owned, claimed or held by the Grantors in and to the following described real property located in Clark County, Nevada and more particularly described as follows:
