16 **JUDGMENT**

17 On October 9, 2009, this Court entered an Order granting summary judgment in favor
18 of Plaintiff. This Judgment reflects the terms of that Order.

19 IT IS ORDERED AND ADJUDGED as follows:

20 Plaintiff Star Insurance has been awarded the amount of \$286,265.78 for damages
21 caused by Defendants' fraud in not obtaining a worker's compensation insurance policy from
22 Plaintiff, all of which was for past damages.

23 Prejudgment interest is awarded in the sum of \$123,084.50, representing interest from
24 the date of service of the Complaint on September 18, 2004.

25 Per the Verified Memorandum of Costs and Disbursements, the total costs incurred
26 by Plaintiff are \$2,732.31.


