
1. Any and all rights of way, reservations, restrictions, easements, mineral exceptions and reservations, and conditions of record;






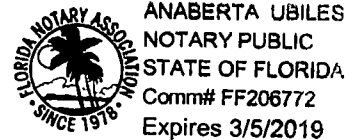
