WHEREAS, Douglas County, is a political subdivision of the State of Nevada (hereafter "Douglas County"), and is required to provide for indigent legal services; and

WHEREAS, Douglas County previously entered into a contract with Jamie C. Henry, Esq. (hereinafter Attorney) to provide legal services to those indigents involved in the Courts in Douglas County for the period of July 1, 2016 through Jun 30, 2017, recorded as Document No. 2016-883229 with the Douglas County, Nevada Recorder (the "Contract"); and

WHEREAS, Attorney desires to revoke the parties' Contract without cause effective September 30, 2016 pursuant to Paragraph 8 of the Contract.

NOW, THEREFORE, in consideration of the agreements herein made, the parties mutually agree to amend the terms of the Contract as follows:

1. REVOCATION OF CONTRACT

In accordance with Attorney's desire to revoke the Contract, the parties mutually agree to revoke and terminate the Contract without cause effective September 30, 2016 in accordance with Paragraph 8 of the Contract. Douglas County agrees to waive the 45 calendar day notice period required under Paragraph 8 of the Contract. After September 30, 2016, the parties will have no further contractual obligations to each other.

2. PAYMENT FOR SERVICES.

Attorney acknowledges that Attorney has been paid the amount of \$48,958.33 by Douglas County under the Contract for services to be provided by Attorney from July 1, 2016 to September 30, 2016. Attorney acknowledges and understands that no further payment is due to Attorney from Douglas County as a result of the termination of the Contract effective September 30, 2016.

3. TRANSITION OF ATTORNEY'S CASES.

Attorney shall continue to represent all assigned clients before all Douglas County Courts through August 22, 2016. After August 22, 2016, Attorney is no longer required to appear on behalf of her assigned clients before all Douglas County Courts, and shall work cooperatively with Douglas County until September 30, 2016 to transition Attorney's assigned clients and cases to alternate counsel identified by Douglas County.

IN WITNESS WHEREOF, the parties hereto have caused this Amendment to Contract for Indigent Legal Services to be signed and intend to be legally bound thereby.
