(A) **"Security Instrument"** means this document, which is dated August 29, 2016, together with all Riders to this document.

(B) **"Borrower"** is BARBARA J. SOURIKOFF, TRUSTEE OF THE BARBARA J. SOURIKOFF REVOCABLE TRUST, U.T.D. 29 JULY 2008. Borrower is the trustor under this Security Instrument.
